

Canon Barnett Homesteads sold

Canon Barnett Homesteads, Erskine Hill, built to provide homes for First World War widows has been sold by the Institute.

At present only four of the 12 flats are occupied and Fay Naylor, Institute Principal, told *Suburb News* that "The ladies living there are protected, their lifetime tenure was written into the title." There had been concern expressed at the RA Council on April 4 that the tenants had been unable to pay their rents and that no one was looking after the building. "There was a short period when this may have been the case but the new owners have now written to the tenants and a representative has visited them" said Fay Naylor who declined to name the new owners who, she said "might not want their names to be divulged"

There had, earlier, been moves to halt the sale by Suburb residents, the Institute's previous Principal John Enderby and the National Association of Almshouses who appealed to the Charity Commissioners. They however ruled that the Institute could sell the property.



There is also a question mark over whether the proceeds of the sale can be transferred to the general fund, as was the money previously collected as an Arts Centre Fund, or should be used for similar charitable housing purposes.

Fay Naylor said "No decision has been taken, most of the money is invested and the Institute Council has yet to consider the matter."

Suburb News understands that the new owner is a Mr Harouni of Alpha Gems in Hatton Garden.

In response to your request for news of birds on the Suburb, my goldfish pond was emptied six times by herons! During this period I tried large tree branches and then large-hole plastic fencing across the pond. Finally a plastic heron alongside. All to no avail.

A couple of years ago I stretched fine green anti-bird fruit tree net across the pond, secured at either end on long solid tree branches. It is virtually invisible and has worked perfectly. At frog spawning time I leave a gap along one side of the pond.

If you have a pond rather than a lake (mine is about 15 feet by 5 feet) I strongly recommend this approach.



Sir,

As you know, one of the most conspicuous features of the Suburb are the many miles of hedging.

For us they provide not only a decorative effect but a mixture of privacy and act as wind breaks and shelter for other plants.

However, for the smaller birds they are an essential habitat providing places where nests can be constructed which can be difficult for predators to reach.

During this period of the year the birds are breeding and it is most important that during this time their habitat is not disturbed. However, many Suburb residents, if not the majority, cut their hedges in this period, a course of action whose timing causes the maximum disturbance to the breeding cycle.

It should be added that this can well mean that hedges should not be cut until June, and though some may consider this untidy, it should enable them to get by with only two cuts during the growing season.

Bearing in mind how sensitive the residents of the Suburb usually are to environmental matters, it is sad to see from an inspection of the hedges during April and May the relatively small number who allow the small birds to nest undisturbed.

Dear Suburb Residents,

This letter is to thank you for the wonderful support given so far by the Residents Association and the Neighbourhood Watch in Hampstead Garden Suburb to the campaign to stop a gaming centre being opened at 107 Golders Green Road, two minutes from many synagogues and the Greek Orthodox Cathedral.

Residents Against Gaming in Golders Green, which has been set up to campaign against the granting of a licence under the Gaming Act to Family Entertainment Ltd. (a firm which runs gaming machine and amusement centres in the West End) has so far succeeded in encouraging over 1,000 people to write individual letters of objection to Barnet Council and another 1,000 to sign a petition along the same lines.

Please, if you haven't done either, write a letter to the Head of Trading Standards, Hatchcroft, The Burroughs, Hendon NW4 4BN as soon as possible, saying among other things that you oppose the granting of a licence because 'there is no demand in the locality' for this kind of establishment. Its location has been chosen to draw on a wide catchment area not - as those of us who are familiar with the locality know - to serve residents. This reason for objection has most force under the law. Proving the same assertion helped Enfield win a similar battle lately.

Please also write to Inspector Garside, Golders Green Police Station, 1069 Finchley Road, NW11 0QE stressing how important it is that the local police also follow Enfield police's example and express their formal opposition to a development which in countless other places has brought an increase in drug-pushers, street crime, burglary and hold-ups in the entire area.

Gaming machines cause real addiction, desperation and crime in children and draw truants. Our police are currently, and inexplicably, unwilling to emulate Enfield, Chichester and Ilford police (to name but a few recently) who have all registered their opposition and helped crime prevention campaigns.

Our final request: please, if you can, help with donations so we can raise the £1,000 needed to fund a professional, independent survey, proving that there is no demand. This will be vital evidence at the hearing - and the possible later appeal stage. 
